- ✓ **1st EUSAIR Forum - February, Athens, Greece**
- ✓ The European Commission launched a new EU Strategy for the Adriatic and Ionian Region in the form of a Communication and an **Action Plan (18 June 2014)**
- ✓ The General Affairs Council meeting adopted conclusions on the European Union Strategy for the Adriatic and Ionian Region (EUSAIR) (on 29-30 September 2014)
- ✓ Endorsement of the EUSAIR by the European Council (24 October 2014)
- ✓ EUSAIR officially launched (18 November 2014)

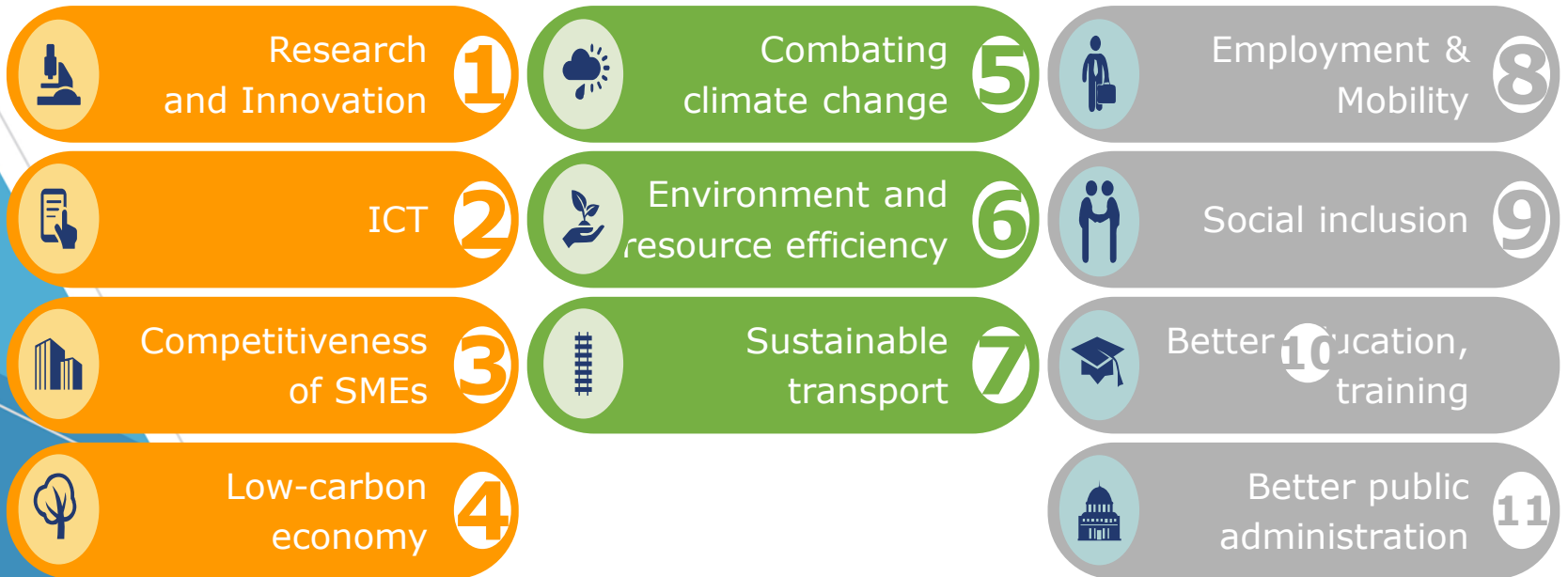
